## Foster Care Agreement

Thank you for agreeing to Foster.

CAR has temporary custody and care of animals rescued and CAR desires to provide a supportive, healthy, and safe environment for each animal in its custody and care; A veterinarian has provided the animal with necessary basic vaccinations. CAR has a reasonable expectation that the animal has been or will be checked by a vet and presumed healthy but depending on the age of the animal all vaccines may not be up to date and additional precautions are necessary. In addition due to the nature of rescue the history of the animal is often unknown and CAR suggests isolating new fosters for several days to ensure no cross contamination perhaps even specifically calling out the incubation period for Parvo. CAR will pay for required veterinary expenses, CAR will provide leash and collar, food and crate if needed.

1. I/We agree that I/We am over 21 years of age.
2. I/We agree to provide CAR access to all parts of the home and property for a home inspection before the application to foster is approved.
3. I/We understand that I/We could be required to provide foster care to the foster animal for an extended and indefinite period of time.
4. I/We agree that the period covered by this agreement is the entire time I/We have custody of the foster animal.
5. I/We understand that CAR provides no guarantee as to the health of the foster animal, and that the foster animal may have socialization problems, and not be housebroken.
6. I/We will take all necessary precautions to prevent the foster animal from either impregnating another animal or becoming impregnated. In the event that such happens, I/We will alert CAR immediately.
7. I/We will not arrange or pay for, or otherwise cause, any elective veterinary procedure to be performed on the foster animal during the period covered by this agreement, without the express written consent of CAR.
8. I/We understand that I/We will not hold CAR in anyway responsible for veterinary or other expenses with regard to our own animal(s).
9. I/We understand that I/We will not hold CAR in anyway responsible for property damage by the foster animal or our own animals.
10. I/We understand that I/We must bring the foster animal to such fostering events as required by CAR.
11. I/We understand that I/We will not hold CAR in anyway responsible for veterinary, or other expenses with
12. I/We agree that I/We am fostering this animal for CAR, and that I/We do not have any right of ownership over the foster animal. I/We also agree to provide CAR reasonable access to the home and property to check on the foster animal at any time that I/We am in possession of the foster animal.
13. If I/We am planning to move at any time during the period covered by this agreement, I/We agree to contact CAR prior to the move with new contact information. I/We understand that CAR has the right to request return of the foster animal based on such a change of residence, and agree to surrender the foster animal to CAR upon request.

14. I/We understand that if the foster animal is the subject of a court case, Defendants, along with their attorneys and veterinarian (the Defense Team) have a right to access the animals in CAR's temporary custody.
15. I/We understand that as long as I/We provide foster care to the foster animal to CAR's satisfaction, I/We will be given the first right of adoption of the foster animal.
16. If at any point I/We can no longer, or do not want to continue to, provide care for the foster animal, I/We agree to arrange for surrender and return of the foster animal back to CAR.
17. I/We agree to contact CAR with any and all questions or concerns about the foster animal or the fostering program. I/We agree that in refuse to comply with any provision of this agreement, CAR has the right to terminate this agreement and also has the right to the immediate surrender and return of the foster animal.
18. I/We have read this Agreement in its entirety, and I/We agree with all the statements and stated agreements in this document.
